No. 28/01/2006-1HR-I -It is hereby notified that 09.11.2022 (Wednesday) and 12.11.2022 (Saturday) shall be observed as Public holiday in all offices, Educational and other institutes of the Government of Haryana, Board & Corporations situated in the jurisdiction of the areas namely Ambala, Charkhi Dadri, Grurgram, Karnal, Kurukshetra, Rewari, Rohtak, Sirsa and Sonapat (except for Gram Panchayat Sambhalkha of Block Ladwa, District Kurukshetra) to poll for Members of Zila Parishads and Panchayat Samitis respectively to enable employees of aforesaid institutions/offices etc. to cast their votes and for those employees located/working beyond the jurisdiction of said Zila Parishads and Panchayat Samitis but are registered voters of said areas to cast their votes.

It is also notified that 09.11.2022 (Wednesday) and 12.11.2022 (Saturday) shall also be observed as Public holiday under section 135B of the Representation of People Act, 1951 applicable under Section 173A of the Haryana Panchayati Raj Act, 1994 for all the factories, Commercial, Establishments, industrial undertakings, trade, shops etc., falling within the jurisdiction, where poll shall be held on 09.11.2022 and 12.11.2022 to enable workers of the factories, commercial establishments, shops etc. located in the areas of the aforesaid Panchayati Raj Institutions to cast their votes.
